THE MAJORITY OF CLIENTS ARE SINGLE WOMEN STRUGGLING TO RAISE THEIR FAMILIES WITH VERY LIMITED RESOURCES. WHWS OPERATES A VOLUNTEER-DRIVEN PARAPROFESSIONAL COUNSELING TALKLINE, PROVIDING FAMILY AND INDIVIDUAL COUNSELING AND SUPPORT GROUPS AND ASSISTS CLIENTS IN ADDRESSING PROBLEMS ARISING FROM POVERTY, DOMESTIC VIOLENCE, DEPRESSION, HUMAN TRAFFICKING, UNEMPLOYMENT, SINGLE PARENTHOOD, AND CHILD ABUSE THROUGH INDIVIDUALIZED CASE MANAGEMENT.
